



BEST LAID PLANS WILL CONTINUE TO CHANGE

- 1. ALL PLANNING AND ACTIONS TAKEN BY THE DISTRICT RELATIVE TO RETURNING TO IN-PERSON INSTRUCTION ARE BASED ON CURRENT EXECUTIVE ORDERS
- While we have a plan in place, all plans are subject to change if there is any new guidance from the State of New Jersey and/ or Department of Education.
- 3. <u>WE HAVE TO ABIDE</u> by Executive Orders and State of New Jersey Guidance.



HEALTH COMMITTEE

- Staff and students will use their own personal masks.
- Scheduled bathroom times and handwashing times, limit number of students in bathroom.
- Reasonable accommodations for staff at increased risk for severe illness as identified by the CDC
- Use flexible worksites and classroom set ups to help maintain a social distance.
- Students will be in cohorts to keep the same students in groups and teachers will go with them.
- Student Accommodations will be addressed on a case-by-case basis
- FULL-TIME NURSES AT ALL THREE BUILDINGS
- Appropriate PPE for all staff when extensive direct contact with a student is anticipated or an assigned task has the potential for an increased risk of exposure to Covid-19.
- Staffulty Screening Questionnaire Before Entering the Building
- CONTACT TRACING \rightarrow Will be done as directed by the Atlantic County Health Department

OPERATIONS COMMITTEE

- Masks must be worn by all entering building, walking in halls and when social distancing is not possible.
- Classrooms set up to meet social distancing requirements
- Grab and Go Meals: Breakfast in the classrooms and lunches go home
- One way travel markers in the hallways
- Scheduled bathroom breaks
- Students bring their own snacks. No sharing of objects
- Students will carry bookbags with materials no locker usage
- Computers travel back and forth with students daily
- Frequent handwashing and hand sanitizing
- Designated room for sick students
- Students will be assigned a schedule for hybrid learning.
- Wednesday Virtual learning day for all.
- Early dismissal schedule for students daily

TECHNOLOGY

- Students will be one-to-one
- Hot Spots available for families who need them
- Online platform being streamlined to one system - OnCourse Classroom LMS
- Online platforms being purchased to make online instruction more robust

FACILITIES COMMITTEE

- Purchased supplies and equipment to disinfect and deep clean all usable space
 - Each occupied room will be cleaned every night with deep cleaning scheduled on Wednesday (After Cohort A) and Fridays (After Cohort B)
- Adequate ventilation to all areas of each school.
- Change air filters on HVAC as per manufacturer's recommendation (ongoing)
- Sanitizers will be installed in classrooms, gymnasiums, cafeterias, vestibules, stairwells and offices.
- Adapting all classrooms to meet the social-distancing requirements, including nurses' treatment areas and isolation areas.
- PPE provided as per recommendation of Director of Special Services, Principals, Nurses and other school administrators for students and all staff

WELLNESS COMMITTEE

- Social Emotional Learning and Resiliency Teams will be identified to increase student and staff support.
- Finalize mental and behavioral health community resource list.
- Plan more outreach to students to address social-emotional needs.
- Counselors and AIM mentors will regularly schedule outreach and in-person activities as allowable.
- A teacher rating scale identifying students who may need extra support.
