Dear Somers Point Families:

Please be aware that the Department of Health released new information that the southeast region on the regional risk matrix, which includes Atlantic County, is <u>no longer listed as Low Risk and is now listed in the Moderate category</u>. This update includes an adjustment to the response guidelines provided by the New Jersey Department Of Health. In an effort to keep open lines of communication with our families, the following is a detailed chart for responses to COVID-19 illness. It is a reference to use when making determinations for the exclusion of staff, students, and close contacts.

We encourage parents and students to continue following the <u>Centers for Disease Control</u> <u>& Prevention</u> promoted safeguards, such as:

- It is important to communicate information related to your child's wellness with the school. Please notify your child's school nurse only if they live with or have had close contact (less than 6 feet; longer than 10 minutes), with someone who is Covid-19 positive. Do not report to school. You will be contacted by the School Nurse regarding further instructions.

You can assist us by remaining vigilant and sensible in your approach by following the Center for Disease Control and New Jersey Department of Health Guidelines for COVID-19.
